Board Member Election Process

January 1 until February 28 is DaVinci Academy's board member recruitment window. Our Board of Directors is composed of eight members: four community members who are appointed by the DaVinci Board of Directors, and four parent members who must go through the election process. Board members serve two year terms that can be renewed up to three terms.

Each January, the DaVinci Board of Directors posts the number of open parent member seats subject to re-election. Interested candidates are then invited to run for these open parent member seats. To qualify, a candidate must be a parent of a current or future-enrolled DaVinci student and be able to pass a criminal background check. Background checks will be completed by DaVinci Academy once the board packet has been turned in. Each candidate must obtain 100 signatures from current DaVinci parents and must submit a biography and purpose statement (reasons why he/she is running) to the board secretary by March 1. This packet contains all the forms needed to submit to the board secretary.
